Category 3-A licenses are approved by the Department Of Conservation (DEC) for pesticide application on ornamental trees, shade trees, and turf grass.

**Suggestion:** When calling prospective companies to treat for EAB, ask and verify if the applicator is also a certified arborist. Arborists (tree professionals) can determine if the tree is a good candidate for treatment. Alternatively, have a certified arborist evaluate your tree and recommend treatment before seeking a pesticide applicator. Find out if the pesticide applicator has experience applying treatments recommended for EAB — it is not a given that a company will do EAB treatments (trunk injection, soil injection, soil drench, or basal trunk spray).
